Dear Judge Furgeson,

On May 6, 2011, Mr. Schepps sent you a letter falsely accusing me of denying Mr. Baron monies to have surgery [Docket No. 524.] On the same day, I sent you a letter with my response—demonstrating why Mr. Baron's accusation against me is wholly without merit. [Docket No 525.] After reflecting on Mr. Schepps' letter I am now supplementing my Friday letter.

It appears from Mr. Schepps' letter that Mr. Baron's surgery was scheduled for Friday, April 29, 2011. The day before, April 28, 2011, Messrs. Schepps and Baron appeared in your courtroom for several hours. Mr. Schepps stood up and made a variety of requests, including, among other things:

- (1) permission to hire a civil trial attorney,
- (2) continuance of the hearing,

- (3) permission to hire a criminal attorney,
- (4) documents from the attorney claimants that Mr. Schepps contends (also falsely) that I am hiding from him, and
- (5) an order requiring me to obtain cash assets through a loan (rather than through the sale of domain names).

What Mr. Schepps did not request, however, money relating to Mr. Baron's April 29, 2011 surgery. In all of Mr. Schepps' instances of making requests to Your Honor, Mr. Schepps never once mentioned the surgery, even though he claims it was scheduled for the next day—and he lacked funds to proceed with the surgery. In addition to the evidence set forth in and attached to my letter from Friday, this additional fact demonstrates further that Messrs. Schepps and Baron are

Again, I would ask that Mr. Schepps please provide me with the name of Mr. Baron's doctor for the \$2,000.00 check and the doctor's address, and I will sign and transmit the check upon receipt of this information. As this is the third request to Mr. Schepps for the same information, I hope this letter closes the loop on this latest fire drill, and I apologize for this issue wasting Your Honor's valuable time.
